香港民研明日發放「我們香港人」有關政府應否強制市民使用 「安心出行」應用程式的調查結果及「疫後復聚指數」

香港民意研究所之香港民意研究計劃(香港民研)將於明日(12月11日)下午舉行發佈會,發放最新一輪「我們香港人意見群組調查」和「疫後復聚指數」。

香港民研於五月底宣佈重整「我們香港人」計劃後,每星期透過研究所的Facebook專 頁邀請市民就社會時事議題提供意見題目,進行網上投票,並把票數最高的一至多條 題目納入「香港民研意見群組」調查,然後公佈結果。本星期進行的是第二十八輪調 查,題目為:「有意見認為政府應強制市民使用『安心出行』應用程式,記錄出行地 點,否則不得進入指定處所,以減低病毒擴散風險。你有多支持或反對這個建議?」 截至今天下午1時,已有超過九千人次參與。結果將於明日(12月11日)下午公佈,敬 請留意。

HKPOP will release tomorrow our "We Hongkongers Survey" on whether the government should make the use of "Leave Home Safe" mobile app mandatory and the "Post-Epidemic Gathering Resumption Index"

The Hong Kong Public Opinion Program (HKPOP) under the Hong Kong Public Opinion Research Institute (HKPORI) will hold a press conference **tomorrow (December 11) afternoon** to release the latest results of "We Hongkongers Panel Survey" and the "Post-Epidemic Gathering Resumption Index".

HKPOP has re-launched its "We Hongkongers" Initiative in late May. Every week we invite Hong Kong people to suggest current affairs survey questions to us via our Facebook page, then cast their votes online to select the question(s) for our "We Hongkongers Panel Survey", and then release the results. This week's survey is the twenty-eighth round. The survey question is "There is a suggestion that the government should make it mandatory for the public to use the 'Leave Home Safe' mobile app before entering designated premises, in order to keep records of their whereabouts so as to minimise the risk of virus transmission. How much do you support or oppose this suggestion?" Up to 1pm today, over 9,000 submissions have been received. The results will be released **tomorrow** (**December 11**) **afternoon**. Please stay tuned.
