香港民研星期五發放「我們香港人」有關被控違反國安法人士 不獲保釋的調查結果及「疫後復聚指數」

香港民意研究所之香港民意研究計劃(香港民研)將於星期五(12月18日)下午舉行發佈會,發放最新一輪「我們香港人意見群組調查」和「疫後復聚指數」。

香港民研於五月底宣佈重整「我們香港人」計劃後,每星期透過研究所的Facebook專頁邀請市民就社會時事議題提供意見題目,進行網上投票,並把票數最高的一至多條題目納入「香港民研意見群組」調查,然後公佈結果。本星期進行的是第二十九輪調查,題目為:「近日有多名被控違反國安法的人士不獲保釋,你認為有關決定有多合理或不合理?」調查已於昨日展開,截至今天上午11時,已有超過七千人次參與。結果將於12月18日(星期五)下午公佈。是次調查為「我們香港人」計劃2020年最後一輪調查,明年會否繼續及以什麼形式進行仍在商討之中,詳情會儘快向市民公布,敬請留意。

## HKPOP will release this Friday our "We Hongkongers Survey" on several people charged with violating the national security law being denied bail and the "Post-Epidemic Gathering Resumption Index"

The Hong Kong Public Opinion Program (HKPOP) under the Hong Kong Public Opinion Research Institute (HKPORI) will hold a press conference this **Friday(December 18) afternoon** to release the latest results of "We Hongkongers Panel Survey" and the "Post-Epidemic Gathering Resumption Index".

HKPOP has re-launched its "We Hongkongers" Initiative in late May. Every week we invite Hong Kong people to suggest current affairs survey questions to us via our Facebook page, then cast their votes online to select the question(s) for our "We Hongkongers Panel Survey", and then release the results. This week's survey is the twenty-ninth round. The survey question is "Recently several people charged with violating the national security law have been denied bail. How reasonable or unreasonable do you think such decisions are?". Up to 11 am today, over 7,000 submissions have been received. The results will be released this **Friday (December 18) afternoon**. This is the last "We Hongkongers Panel Survey" in 2020, whether it will continue next year and in what form is still under discussion, details will be announced to the public as soon as possible. Please stay tuned.
