HKPOP will release today our "We Hongkongers Survey" on whether Hong Kong Judiciary should conform to the principle of "patriots ruling Hong Kong" and the "Post-Epidemic Gathering Resumption Index"

The Hong Kong Public Opinion Program (HKPOP) under the Hong Kong Public Opinion Research Institute (HKPORI) will hold a press conference **today (December 4) afternoon** to release the latest results of "We Hongkongers Panel Survey" and the "Post-Epidemic Gathering Resumption Index".

HKPOP has re-launched its "We Hongkongers" Initiative in late May. Every week we invite Hong Kong people to suggest current affairs survey questions to us via our Facebook page, then cast their votes online to select the question(s) for our "We Hongkongers Panel Survey", and then release the results. The survey of this week is the twenty-seventh round. The survey question is "There is a saying the Hong Kong Judiciary should conform to the principle of 'patriots ruling Hong Kong'. How much do you support or oppose this saying?" Up to 9 am today, near 5,000 submissions have been received. The results will be released **today (December 4) afternoon**. Please stay tuned.
