HKPOP will release tomorrow People's Satisfaction with the Disciplinary Forces and the "Post-Epidemic Gathering Resumption Index"

The Hong Kong Public Opinion Program (HKPOP) under the Hong Kong Public Opinion Research Institute (HKPORI) will hold a press conference **tomorrow (December 8) afternoon** to release the latest results of People's Satisfaction with the Disciplinary Forces and the "Post-Epidemic Gathering Resumption Index".

HKPOP has re-launched its "We Hongkongers" Initiative in late May. Every week we invite Hong Kong people to suggest current affairs survey questions to us via our Facebook page, then cast their votes online to select the question(s) for our "We Hongkongers Panel Survey", and then release the results. This week's survey is the twenty-eighth round. The survey question is "There is a suggestion that the government should make it mandatory for the public to use the 'Leave Home Safe' mobile app before entering designated premises, in order to keep records of their whereabouts so as to minimise the risk of virus transmission. How much do you support or oppose this suggestion?". Data collection will start later today and the results will be released on **Friday** (**December 11**) **afternoon**. Please stay tuned.
