### **HKPOP will release next Tuesday popularity figures of CE and the government, “Community Health Survey” Report No. 11, and “Community Health Information System” Report No. 5**

The Hong Kong Public Opinion Program (HKPOP) under the Hong Kong Public Opinion Research Institute (HKPORI) will hold a press conference **next Tuesday (April 21)** afternoon to release the latest survey results on popularity figures of the Chief Executive and the government.
