## 香港民研明日發放兩岸領導人評分 及多項「疫後復常指數」

香港民意研究所之香港民意研究計劃 (香港民研) 將於<u>明天 (8 月 4 日)</u> 下午舉行發布會,發放兩岸領導人評分。

香港民研於五月底宣佈重整「我們香港人」計劃後,每星期透過研究所的 Facebook 專頁邀請市民就社會時事議題提供意見題目,進行網上投票,並把票數最高的一至多條題目納入「香港民研意見群組」調查,然後公布結果。本星期進行的是第十一輪調查,題目為:「在原定 9 月 6 日舉行的立法會選舉中,多名選舉主任一共取消了十二名參選人的參選資格,理由是參選人沒有真誠擁護《基本法》和保證效忠香港特區。整體而言,你有多支持或反對這些選舉主任的決定?」,調查已經開始。

## HKPOP will release tomorrow the Cross-strait Leaders' Ratings and some "Post-Epidemic Normality Resumption Indexes"

The Hong Kong Public Opinion Program (HKPOP) under the Hong Kong Public Opinion Research Institute (HKPORI) will hold a press conference **tomorrow (August 4) afternoon** to release the cross-strait leaders' ratings.

HKPOP has re-launched its "We Hongkongers" Initiative in late May. Every week we invite Hong Kong people to suggest current affairs survey questions to us via its Facebook page, then cast their votes online to select the question(s) for its "We Hongkongers Panel Survey", and then release the results. This week's survey is the eleventh round and the question is: "For the Legislative Council election originally scheduled for September 6, a number of returning officers have disqualified twelve candidates in total, for reasons that they do not genuinely uphold the Basic Law and swear allegiance to Hong Kong Special Administrative Region. How much do you in general support or oppose these decisions made by the returning officers?" and the survey has already started.
