香港民研明天發放「我們香港人意見群組調查」 和「疫後復聚指數」及介紹民主派初選觀察計劃

香港民意研究所之香港民意研究計劃（香港民研）重整「我們香港人」計劃後，每星期透過研究所的 Facebook 專頁邀請市民就社會時事議題提供意見題目，然後進行網上投票，並把票數最高的一至多條題目納入「香港民研意見群組」調查，然後公布結果。本星期進行的是第六輪調查，題目為：「假如中央政府正式在香港推行港區國家安全法，你有多支持或反對美國政府根據《美港關係法案》，不再給予香港一些有別於中國的特殊待遇，包括獨立關稅區、經貿雙邊關係、自由兌換貨幣及簽證待遇等？」，截至今今天上午 9 時已有超過八千五百人參與調查，結果將於明天下午 (7 月 3 日) 公布。

Press Invitation

HKPOP will release tomorrow “We Hongkongers Panel Survey”, “Post-Epidemic Gathering Resumption Index” and introduce the Democrats Primary Election Observation Project

The Hong Kong Public Opinion Program (HKPOP) under the Hong Kong Public Opinion Research Institute (HKPORI) re-launched its “We Hongkongers” Initiative, to invite Hong Kong people to suggest current affairs survey questions to HKPOP via its Facebook page and then cast their votes online to select the question(s) for its “We Hongkongers Panel Survey”, and then release the results. This week’s survey is the sixth round and the question is: “If the Central Government formally implements the Hong Kong National Security Law, how much do you support or oppose the U.S. Government to revoke Hong Kong’s preferential treatment from that given to Mainland China according to the ‘United States - Hong Kong Policy Act’, including a separate customs territory, bilateral economic and trade relations, free currency conversion, visa entitlements, etc.?” Up to 9am this morning, over 8,500 citizens have participated in the survey, the results will be announced **tomorrow (July 3) afternoon.**

HKPOP will also release the latest reading of the “Post-Epidemic Gathering Resumption Index” (PEGRI) tomorrow, while its reading today (July 2) is 61.4.
