## HKPOP will release this Friday the survey results on "National Security Law"

In light of current political turbulence, the Hong Kong Public Opinion Program (HKPOP) under the Hong Kong Public Opinion Research Institute (HKPORI) has re-launched its "We Hongkongers" Initiative yesterday. We invite Hong Kong people to suggest current affairs survey questions to us on a weekly basis via our Facebook page and then cast their vote online to select question(s) for our "PopPanel survey". Results will be announced at our press conference. Citizens are welcome to provide questions and vote actively.

The survey this week has two questions on the legislation of "National Security Law", namely: "The National People's Congress will deliberate on a draft decision to establish the legal system and enforcement mechanisms to safeguard national security in Hong Kong, delegating to its Standing Committee to start the lawmaking process. How much do you support or oppose the draft decision?" and "If the National People's Congress decides to establish the legal system and enforcement mechanisms to safeguard national security in Hong Kong, how positive or negative do you think will be its impact on the stability of the Hong Kong society?" The results will be released at a press conference this Friday (May 29) afternoon. The media is invited to send representatives to attend the press conference, details are as follows:
