Press Invitation

HKPOP Press Conference: "We Hongkongers" and Policy Address Follow-up Survey

Hong Kong Public Opinion Program (HKPOP) under the Hong Kong Public Opinion Research Institute (HKPORI) will hold a press conference tomorrow, where HKPOP will announce the details of "We Hongkongers 我們香港人" Initiative, including the crowdfunding arrangement and the results of first round of rolling survey. With reference to the petition website "We the People" by the White House of the United States, "We Hongkongers" Initiative aims to reflect public sentiment by conducting scientific research on any issues raised by Hong Kong citizens. If any person can mobilize more than 10,000 "petitions", his or her suggested questions will be included in the survey after passing a verification process. The pilot rolling survey of "We Hongkongers" started officially last Thursday (October 17), with a target sample size of at least 334 per rolling day. The following 5 questions were selected for pilot study:

- O Q1: There are views in the society saying the 7.21 incident involved collusion of the Police Force and triads. How much do you agree or disagree with this view?
- O Q2: There are views in the society saying there are Chinese People's Police or People's Armed Police Force in the Police Force. How much do you believe in this view?
- o Q3: There are views in the society saying the District Council Election should not be held as scheduled. How much do you support or oppose postponing the District Council Election?
- o Q4: Some candidates of the District Council Election are being questioned on their political stance because of speeches related to the slogan "Liberate Hong Kong, revolution of our times". Do you think returning officers should take this into consideration when ruling on candidacy?
- O Q5: The U.S. Congress is reviewing the Hong Kong Human Rights and Democracy Act, which would sanction people thought to have infringed human rights in Hong Kong. How much do you support or oppose this Act?

First round results of above-mentioned pilot study will be announced at the press conference tomorrow. Media are invited to send representatives to attend the press conference and to sponsor the above-mentioned rolling survey, at \$8,000 per question. All sponsors will receive the results in advance. At the same time, HKPOP will release the findings on the Policy Address first follow-up survey, and honorary commentators will interpret the results. Sponsorship is also welcome.
