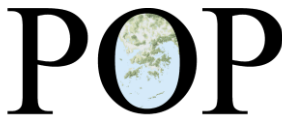

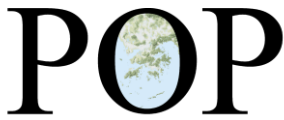

1. Please join the Zoom meeting at least 10 minutes before the press conference starts (i.e. by 2:20pm for meetings to start at 2:30pm) by using the following weblink:

3. Please name or rename your account showing your name and your organisation; people with unclear or sceptical identification may be refused admission.
4. Wait for the host to admit you into the Zoom Meeting Room.
5. During the Q&A session, when you want to raise a question, please submit it in writing to the host at the Zoom Chat Room; this is a backup measure so that in case of technical problem, your question may be read out by the moderator.
6. The host will then give you signal when it is almost your turn to ask your question.
7. Please then unmute your Zoom session microphone to ask your question; in case technical problems creep in, the moderator will read the question for you.
8. No foul language or personal attack is allowed; the host or the moderator may sharp cut the conversation when this happens.
