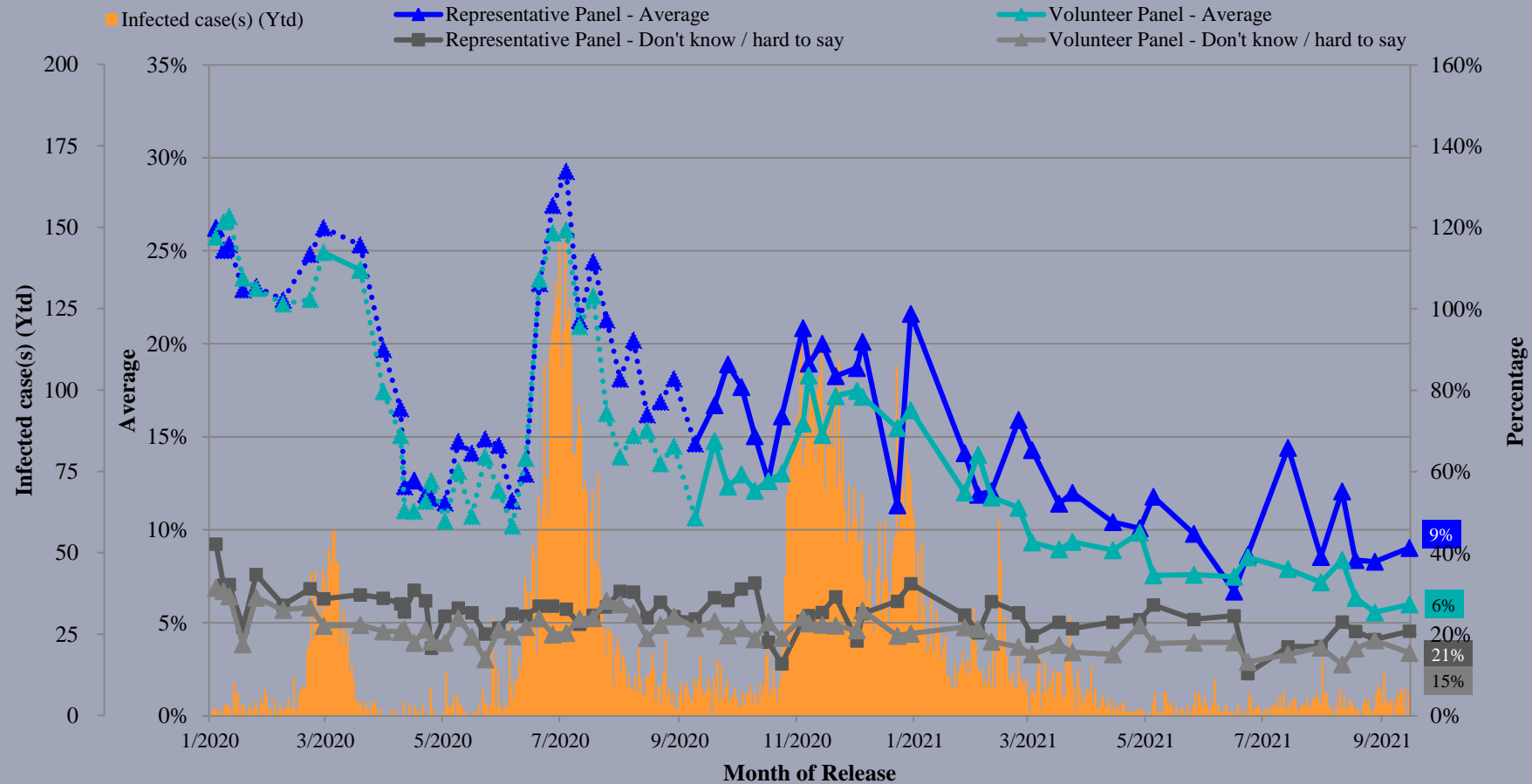

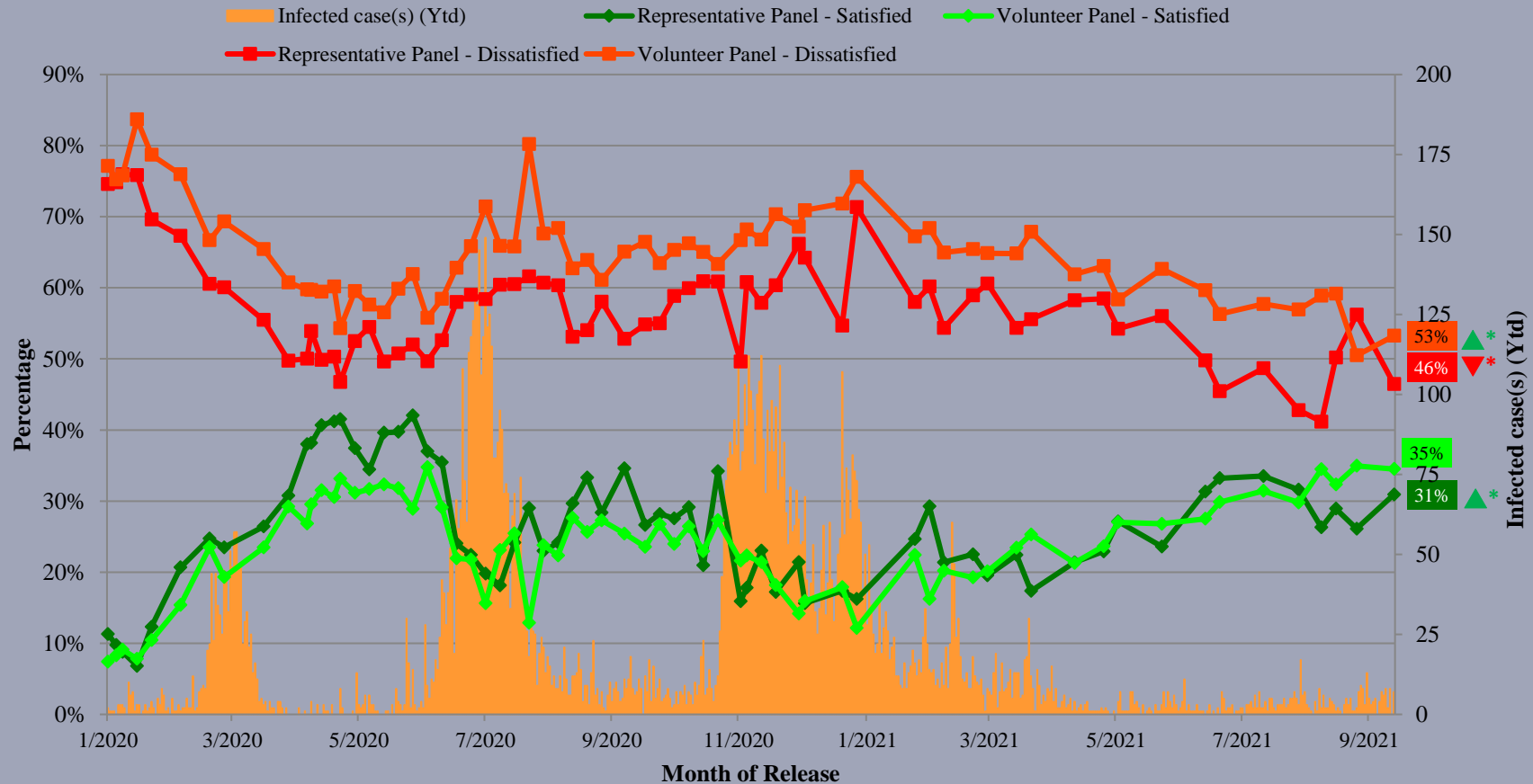


Appraisal of HK Government's performance in handling novel coronavirus pneumonia

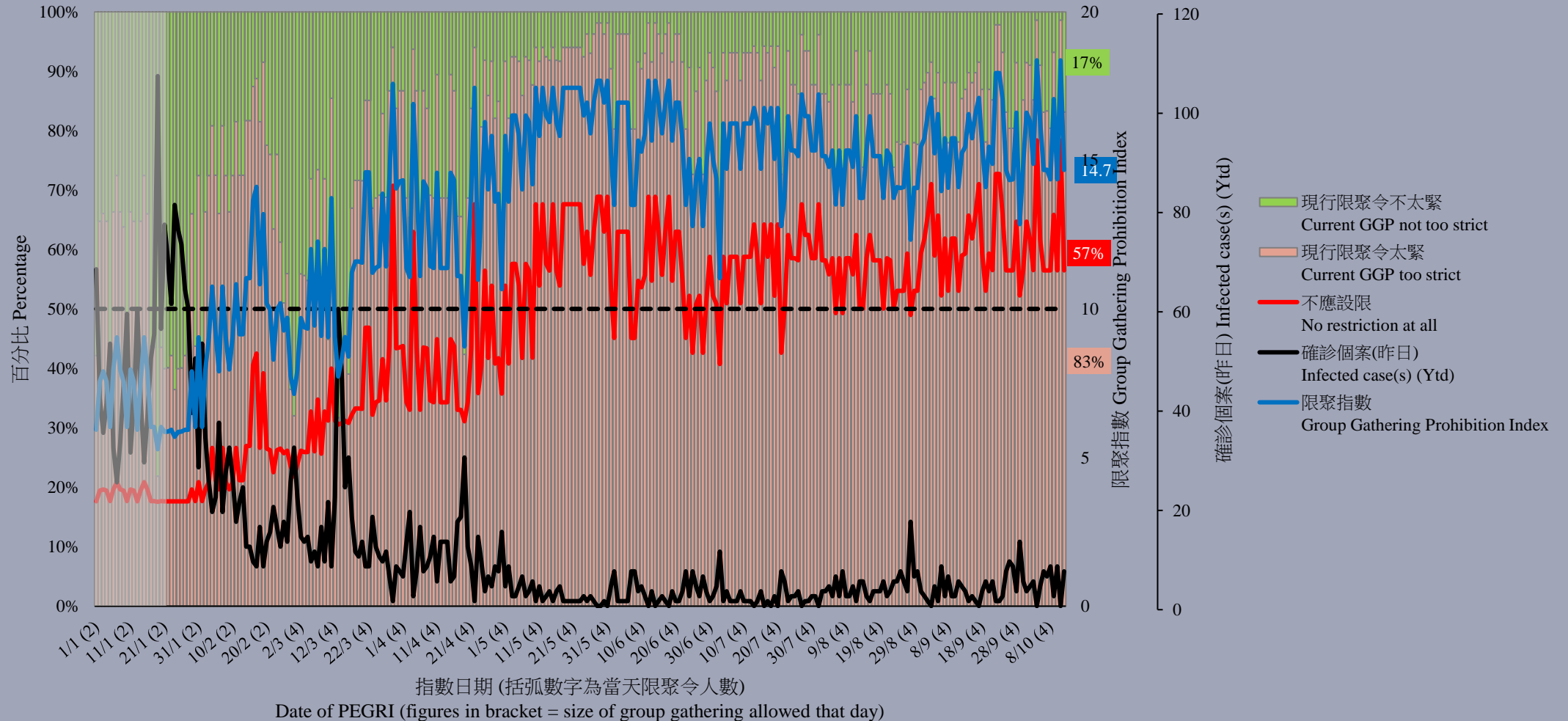

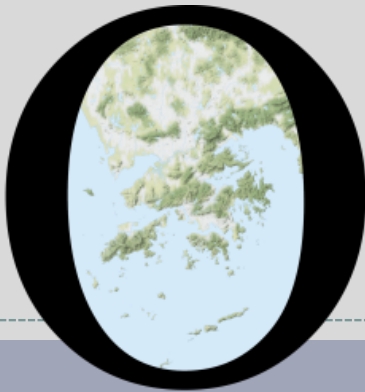

香港教育中心商會副主席任偉豪指出：「在港府的角度而言，雖已與中央協商通關多時，直至現在還未明朗，這可能會令市民失去港府與中央政府協作能力的信心。特別是上星期特首發表的施政報告中涉及大量大灣區規劃，會令人懷疑施政報告中的大計是否真的能夠實現。不過另一方面，我認為先讓香港觀察一下澳門先行通關的情況也是好事。」

Vice Chairman of The Hong Kong Chamber of Education Centres Yam Wai Ho observed, “From the perspective of the Hong Kong Government, the traveller clearance has been negotiated with the Central Government for a long time, and it has not been as clear until now. This may cause the public to lose confidence in the ability of the Hong Kong Government to cooperate with the Central Government. In particular, the policy address released by the Chief Executive last week involved many plans for the Greater Bay Area, which will make people doubt whether the big plans in the policy address can really be realized. But on the other hand, I think it is also good to let Hong Kong observe the situation of Macau’s traveller clearance first.”

- Date of survey: 4-7/10/2021
- Survey method: Random telephone survey conducted by real interviewers
- Target population: Cantonese-speaking Hong Kong residents aged 18 or above
- Sample size: 1,010 (including 508 landline and 502 mobile samples)
- Effective response rate: 62.9%
- Sampling error: Sampling error of percentages not more than +/-3%, that of net values not more than +/-5% and that of ratings not more than +/-2.1 at 95% conf. level
- Weighting method: Rim-weighted according to figures provided by the Census and Statistics Department. The gender-age distribution of the Hong Kong population came from “Mid-year population for 2020”, while the educational attainment (highest level attended) distribution and economic activity status distribution came from “Women and Men in Hong Kong - Key Statistics (2020 Edition)”.

- Our latest survey shows that the popularity rating of CE Carrie Lam is 38.3 marks, with 28% of respondents giving her 0 mark. Her approval rate is 24%, disapproval rate 59%, giving a net popularity of negative 35 percentage points. The rating and net popularity have increased significantly compared to half a month ago, registering **record highs** since early June 2019.

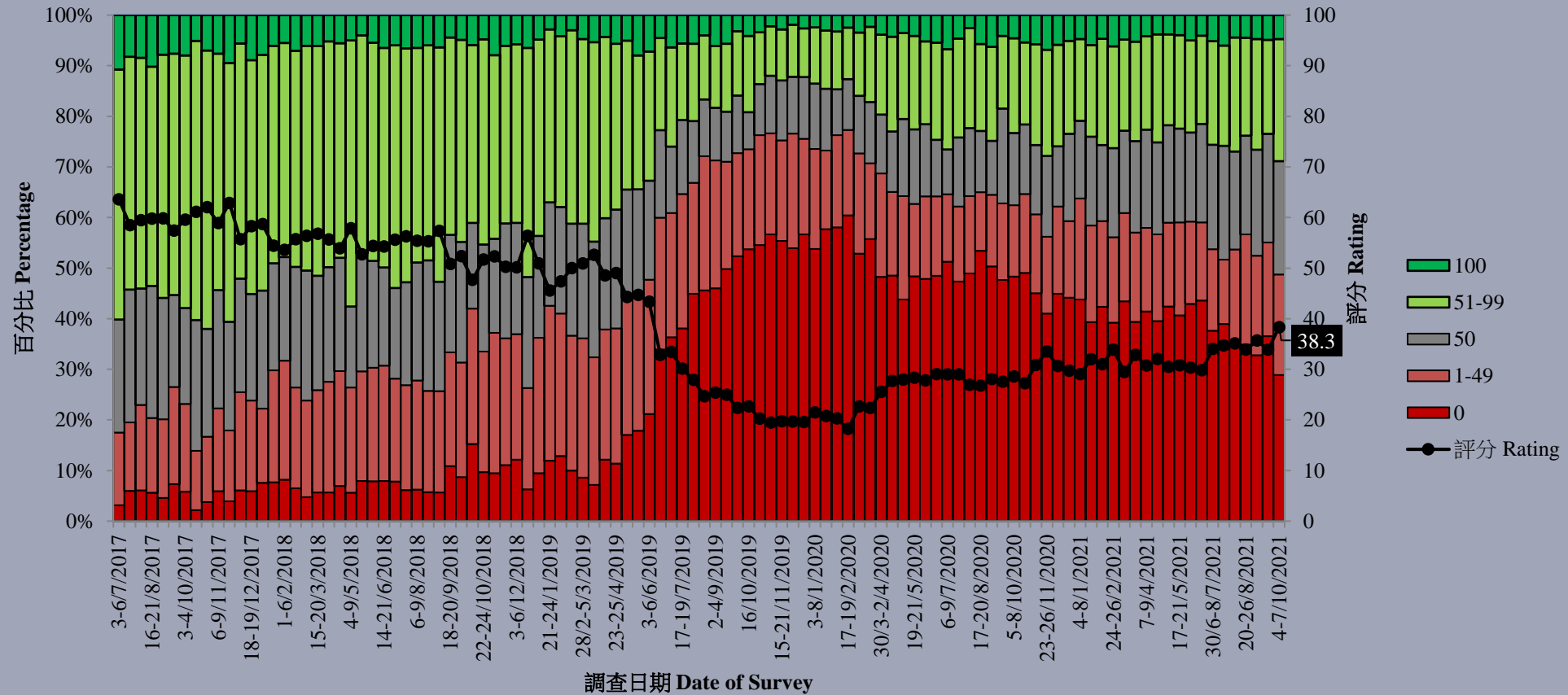
[#] POP conducted a Policy Address instant survey in between two tracking surveys, but because our tracking surveys do not use online samples, and our latest survey started two days before the Policy Address, it is better to compare the latest figures with those collected in our previous survey.

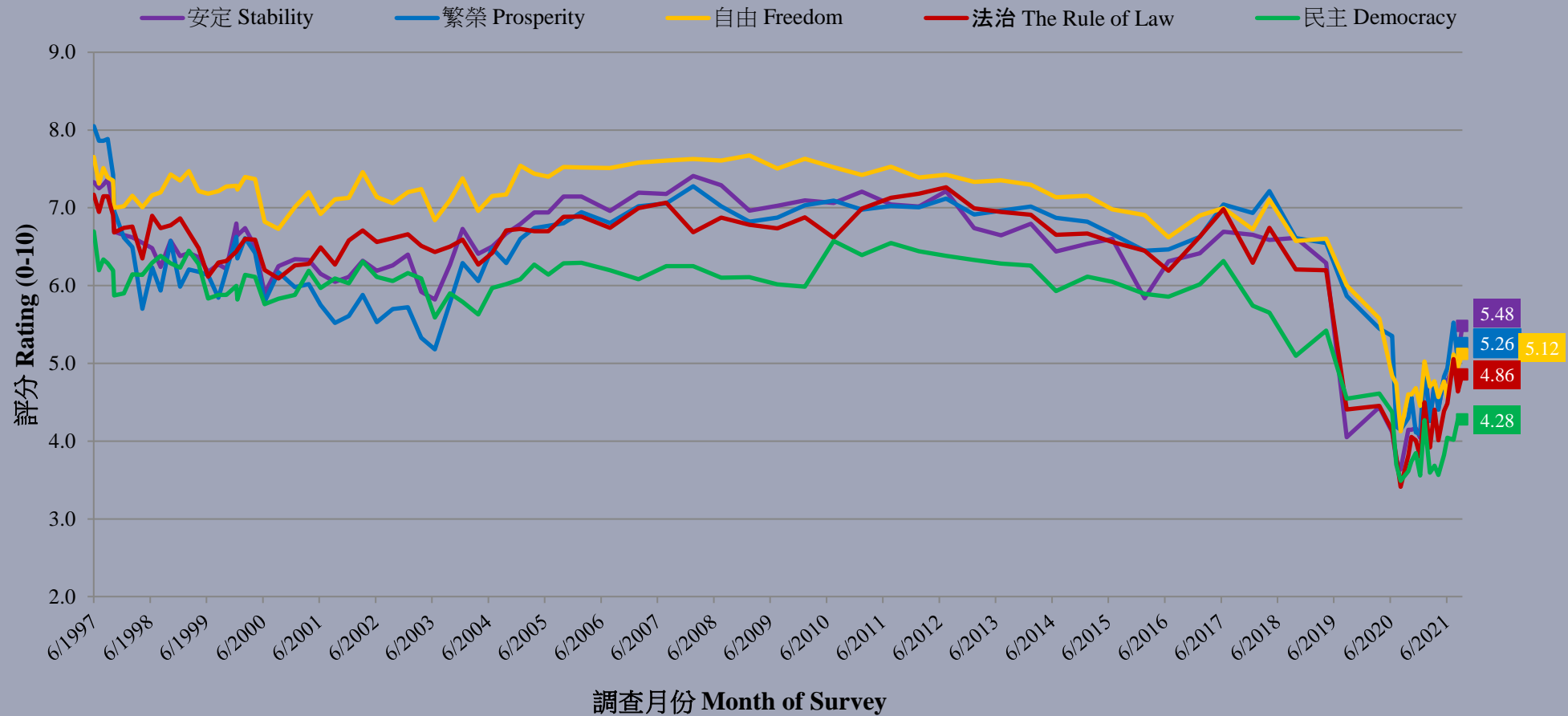
- On a scale of 0 to 10, people's ratings on the five core social indicators ranked from the highest to the lowest are “stability”, “prosperity”, “freedom”, “rule of law” and “democracy”. Compared with a month ago, the “prosperity” and “rule of law” indicators both receded significantly, while the “stability” indicator has registered a new high since May 2019.
